

**Specific Terms and Conditions for “Kiple Ambassador” Campaign
 (“Specific T&C”)**

A. Description of Campaign

1.	Organiser	Kiplepay Sdn Bhd (Registration No.: [200001007771 (510377-P)]) <i>(hereinafter referred as “Kiple”)</i>
2.	Name of Campaign	Kiple Ambassador Program <i>Note: By being a Kiple Ambassador, you stand a chance to earn up RM700 monthly</i>
3.	Brief Description of Campaign	This campaign is open to all Kiple users. Kiple Ambassadors will share their unique referral code to any individual and obtain an incentive when that particular individual signs up with Kiple and performs one (1) payment transaction. Kiple Ambassadors may earn more incentive when they refer any individual aged 18-25 years old.
4.	Campaign Mechanics	How to become a Kiple Ambassador? <ol style="list-style-type: none"> 1. Register as a Kiple Ambassador on https://ambassador.kiple.com with your personal referral code. The code can be retrieved via the Kiple app in the following manner: “Kiple app > Account > Refer A Friend” 2. Upon successful registration, the Kiple Ambassador can share their personal referral code with any individual to download the Kiple app and to sign up for an account. 3. Each successful referral (sign up for Kiple and perform at least 1 payment transaction) will grant an incentive to the Kiple Ambassador. 4. The ambassador is entitled to an additional incentive when the referral is made to students aged between 18-25 years old. 5. All sign-ups and payment transaction by the referral must be done within the same month. If either one of the criteria is not met within the same month, the ambassador is not entitled for the incentive that month. 6. If a referral has signed up and performed a payment transaction during the first month, the referral will not be accounted for in the total referral count in the subsequent months. 7. The accumulated incentive amount will be credited to the Kiple Ambassador’s Kiple wallet directly by the first week of the following month, and the cycle will be

5.	Campaign Terms	<ol style="list-style-type: none"> This Campaign is applicable to all Kiple users. Campaign rewards will be rebated in the form of credits via Kiple wallet by the first week of the following month. Example: Earnings from 1st-31st Oct will be credited into Ambassador's Kiple wallet by 7th November. The number of referrals is non-cumulative – it will be renewed at the first calendar day of each month. Example: Amir referred 10 friends to join in the month of October. He then refers another friend on 1st Nov. He will only receive the incentive amount for 10 referrals on the first week of November. The incentive for the 11th friend will be reimbursed on the first week of December instead. The referral is to perform a minimum of 1 payment transaction of any amount for the ambassador to receive the incentive. All payment transactions must be done within the Kiple wallet only. 6.	Eligibility Criteria	<ol style="list-style-type: none"> The Campaign is open to all Malaysians aged 18 years and above starting from 4 October 2021. The Campaign is open to all foreign residents aged 18 years and above as of 4 October 2021, save for

		nationalities where their countries are sanctioned in Malaysia.
7.	Campaign Period	4 October 2021 onwards

B. General
